Making Panel of Inspecting Officers for various Competitive Examinations conducted by the Staff Selection Commission (Central Region), Prayagraj.

Staff Selection Commission conducts competitive examinations for recruitment to various Group 'C' and Group 'B' posts in the Ministries, attached and subordinate offices of the Government of India.

- (i) Retired Gazetted/equivalent officers of Government of India, CPSE, State Government, Public Sector Banks;
- (ii) Ex- servicemen of minimum Junior Commissioned Officers Rank;
- (iii) Serving/retired Government Professors, Lecturers, Post Graduate Teachers of Government/Government-aided High School and above.

The remuneration as per approved rates to the Inspecting Officers will be transferred by the Commission through PFMS (PFMS Proforma enclosed) after getting the inspection report.
