2. The CST will consist of one **objective type paper of 200 marks**. The paper will contain multiple choice questions in four subjects each of 50 marks. The subjects are (i) General Intelligence (ii) English Language (Basic knowledge) (iii) Quantitative Aptitude and (iv) General Awareness. The duration of the paper will be of two hours. There will be negative marking of 0.25 mark for each wrong answer. For detailed syllabus, candidates may click on the link given below this Notice.

- 3. Common candidates who have applied for different categories of posts advertised by one region or different posts advertised by different regions will appear for the **test only in one centre in one region**.
- 4. The marks secured by the candidate in Common Screening Test will be taken into account for all the categories of posts applied for by the candidates.
- 5. Where the candidate has applied for more than one post in the same region, **only one AC** has been issued to the candidate for all the posts for which he has applied.
- 6. Where the candidate has applied for multiple posts/Regions and receives more than one AC, the candidates are advised to **bring all Admission Certificate** received by him for CST for the different posts applied for by him and to surrender the same to the **invigilator**.
- 7. The common candidates (who have applied for post advertised by different regions) are also advised to inform, in writing, to Regional Director/Deputy Director concerned from whom he has received Admission Certificate for other posts, giving details of the name of the Region from where he/she has appeared for the CST and the Roll. No. Cat., Advt. No. etc.
- 8. It is also to inform the after careful scrutiny of the application form received against the above mentioned categories of post, list of rejected applications were posted on the web-site of this Region. The candidates were also advised to intimate this office about their objection, if any. The objections received from the candidates were examined and suitable action was taken accordingly. Therefore, those candidates whose applications were already rejected are advised not to make any correspondence in this regard.
