Essential Qualification (EQ) for the Post:-

- a) Bachelor's Degree in Textile Technology or three years diploma in Handloom Technology or Handlooms & Textile Technology from a recognised University or Institute. AND
- b) Two years practical experience as shift-in-charge for Degree Holder's and three years for Diploma Holders in a textile weaving or production establishment or corporation or institution, out of which, at least one year should be in handlooms dealing with all the different techniques of production as well as analysis and costing of handloom fabrics including traditional varieties and special fabrics or all fibres and there blends, dismantling, erecting and working of different types of handlooms and handloom accessories such as jacquards, dobbies, jalas, and experience of guiding and controlling the activities of the weaver's in the production of fabrics with new designs and textures as well as organise production of commercial samples using improved accessories and appropriate techniques of production.
- 1. Initially 20 candidates were shortlisted by the Commission in the result published on 12.04.2021 for further stage of recruitment in the above mentioned post category.
